

## **Mo•Ments 2025 Privacy Policy – For Registrants (“Event Privacy Policy”)**

**Last Updated: 28 March 2025**

### **Introduction**

This Event Privacy Policy describes how Ant International and its affiliates (“we,” “us,” or “our”) collect, use, store, disclose, and transfer (collectively, “Process” or “Processing”) your information, including personally identifiable information (“Personal Data”) as a participant or registrant in relation to your registration and attendance at Mo•Ments 2025 event (the “Event”).

This Event Privacy Statement applies to your Personal Data we receive prior to or from the Event, including Personal Data in the possession of organisations who are not our affiliates which we have engaged to Process the Personal Data for our purposes stated in the Event Privacy Statement.

### **By registering and/or participating in the Event:**

- a. you acknowledge and consent to the Processing of your Personal Data as described in this Event Privacy Policy; and**
- b. you agree to our collection, use, disclosure, transfer, storage and/or processing of any Personal Data in accordance with this Event Privacy Policy.**

### **How Personal Data is Used**

We collect your Personal Data through our event registration process, including information you provide directly via registration forms, as well as through any other webpages we set up as the Event organiser. We Process this data based on the performance of a contract with you (i.e. your Event registration) and our legitimate interests in managing the Event. This includes, but is not limited to:

1. verifying your identity and responding to your requests/queries relating to the Event;
2. processing your registration for the Event;
3. contacting you in relation to Event updates and arrangements;
4. organising and managing the Event;
5. managing Event attendees;
6. evaluating and improving our future events
7. conducting post-event surveys or feedback collection; and
8. any other purposes related to the Event.

### **Personal Data Collection**

By registering and/or attending the Event, you represent and warrant that you are the individual registering for the Event or have the express authority to register on behalf of that individual.

If you are registering on behalf of another individual, you represent and warrant that you have obtained their consent to provide their Personal Data for the purposes set out in this Event Privacy Policy.

When you register for, participate in, or attend the Event, we may Process the following information, including your Personal Data that you voluntarily provide, which may include, but is not limited to:

1. Personal Details: Name, surname, nickname, gender, nationality, signature, etc.;
2. Contact Details: Addresses, phone numbers, email addresses, or other information that permits us to contact you;
3. Employment Details: Occupation, job title or position, organisation name, etc.;
4. Identification Details: Identification number, passport number, or other government-issued identification details;
5. Account and Payment Details: Registration details, payment records, billing information, including debit or credit card details (where applicable);
6. Photographs and Recordings: A photograph submitted as part of your Event registration, as well as photographs, video and voice recordings captured at our premises or during the Event (where applicable);
7. Travel and Accommodation Details: Flight details, arrival and departure times, and related logistic information, etc.;
8. Marketing and Communications Details: Your preferences for receiving marketing details and communication preferences, etc.

We may also combine information collected from various sources, including details provided during registration, when you communicate with us via Event registration webpages, email, phone, SMS, or other electronic means, or data collected during the Event, such as through surveys or participation in event activities.

If you fail to provide the requested Personal Data, we may be unable to offer our services to you, including processing your registration or allowing your participation in the Event.

### **Disclosure of Personal Data**

We may share your Personal Data for the purposes indicated under How Personal Data is Used.

We will only disclose your Personal Data when necessary and where we have a legitimate reason to Process it. This may include sharing your Personal Data with the following parties:

1. Affiliates, Co-organisers, and Service Providers: Any affiliated entities, co-organisers, event partners, agents, contractors, or third-party service providers engaged in managing, organising, hosting our Event websites, or delivering services for the Event, etc.;
2. Financial Institutions and Payment Service Providers: Where necessary, to facilitate transactions related to your participation in the Event;
3. Attendee List and Networking: Information about attendee visibility and networking is described in the Attendee List and Networking section of this Event Privacy Policy.
4. Other Third Parties: Any third party with your consent or at your instruction in connection with the Event;
5. Legal Requirements: We may disclose your Personal Data if required to do so by law (including, without limitation, responding to a subpoena or request from law enforcement, court or government agency) or in the good faith belief that such action is necessary (i) to comply with a legal obligation, (ii) to protect or defend our rights, interests or property or that of other customers or users, (iii) to act in urgent circumstances to protect the personal

safety of users of the Event or the public, or (iv) to protect against legal liability, or (v) where we consider that such use or disclosure is necessary to respond to any claims or legal process, or where we suspect that fraud or unlawful activity has been, is being or may be engaged in.

### **Attendee List and Networking**

To facilitate networking and professional connections, we may make certain attendee details visible to other registered attendees of the Event. This includes your name, organisation/company name, job title, and email address to enable attendees to connect, exchange messages, etc. This may be available before, during, and after the Event to allow attendees to network effectively.

We will not disclose your phone numbers or other personal contact details to other attendees.

If you do not wish to have your details included in the attendee list, you may opt out by contacting us via the details provided in the Contact Us section.

### **Storage and Retention of Personal Data**

We will only retain your Personal Data for as long as is reasonably required to fulfil the Processing purposes specified in this Event Privacy Statement and as required by applicable laws. We will delete, destroy or anonymise the Personal Data Processed once its retention no longer serves the purposes mentioned in this Event Privacy Statement, or until you request us to delete it and we are able to do so.

### **Third Party Services and Sites**

We may provide links to third party websites and services (including the websites, services and mobile applications of our partners) for your convenience and information. These services and websites may operate independently from us. Linked services and websites may have their own privacy notices or policies, which we strongly suggest you review if you visit any linked services and websites.

To the extent any linked websites or services you visit are not owned or controlled by us, we:

- (i) are not responsible for the content, availability, or practices of such websites or services;
- (ii) do not endorse or make any representations regarding these websites or services; and
- (iii) are not responsible for any use of these websites or services by you, including any transactions, interactions, or data exchanges.

We shall not be liable for any loss, damage, or harm arising from your access to or use of such third-party websites or services, including but not limited to any security breaches, data misuse, service failures, or any other consequences resulting from your interaction with such third parties. Your use of third-party services and websites is entirely at your own risk.

## **Data Transfer**

We are a global business and your Personal Data may be Processed outside the country where you reside. Regardless of where your Personal Data is Processed, we will implement appropriate measures to ensure that your Personal Data remains protected and secure in accordance with applicable data protection laws.

## **Your Rights with respect to your Personal Data**

In accordance with applicable data protection and privacy laws and regulations, you may have the right to access, obtain a copy of, correct, request the erasure or transfer of, and object to or restrict the processing of your Personal Data. If we rely on your consent for processing your Personal Data, you may withdraw your consent at any time. You also have the right to lodge a complaint with the relevant government authorities under applicable data protection laws. These rights are subject to the limitations set out in applicable data protection laws. For further information on these rights and the circumstances in which they apply, or to exercise your rights, please contact us using the details provided in the Contact Us section below.

## **Photography, Audio and Visual Recording**

By attending the Event, you acknowledge and agree to being photographed, filmed or otherwise recorded during the Event. You further consent that we may use your name, voice, photos, video or film clips, and/or other visual likeness in the Event for advertising and/or commercial purposes and/or for any other lawful purpose in any media or format now or hereafter known without further compensation (financial or otherwise), permission or notification.
